resistance management, AWARD TURF FERTILIZER with 0.38% BARRICADE HERBICIDE is a Group 3 herbicide. Any weed population may contain or develop plants naturally resistant to AWARD TURF FERTILIZER with 0.38% BARRICADE HERBICIDE and other Group 3 herbicides. The resistant biotypes may dominate the weed population if these herbicides are used repeatedly in the same field. Appropriate resistance management strategies should be followed.

To delay herbicide resistance take one or more of the following steps:
